**ADVISORY**

This is further to our Advisory dated September 01, 2020 regarding providing Emergency Certificate (EC) **on gratis basis** by Embassy of India (EoI), Abu Dhabi and Consulate General of India (CGI), Dubai to Indian nationals, who are not having valid travel documents to travel back to India.

2. The Embassy of India (EoI), Abu Dhabi and the Consulate General of India (CGI), Dubai welcome the decision of the UAE authorities to extend the validity of the visa fine waiver (Amnesty) scheme till December 31, 2020 **for those foreign nationals whose visas expired before March 1, 2020.**

3. In this regard, applicants are advised to fill the online application form for ECs (<https://embassy.passportindia.gov.in/>) and submit them in person at the BLS center with the following documents:

- Two recent passport size photographs, showing full frontal view of face against light background;
- Original expired/damaged passport/copy of the previous/lost passport or details of the previous/lost passport (**any one of this**);
- In instances, where an applicant is not in possession of the copy of the passport or does not remember his/her passport number, an original/photo copy of any other photo identity document issued by the Government of India viz; Aadhar Card, Driving License, Voter ID Card, Ration Card or domicile/nativity certificate issued by the concerned state authorities in India, held by the applicant, can also be provided along with the EC application to establish the applicant's identity and nationality. However, this process will require verification and a personal interview at the Embassy of India in Abu Dhabi/Consulate General of India in Dubai.

4. Applicants are advised to submit any of the above mentioned documents along with the EC application printout from the weblink and 2 photographs, at the nearest BLS center on all working days as per following timings:

- Abu Dhabi & Al Ain : 9 AM to 4 PM
- Dubai and other Northern Emirates: 5 PM to 6 PM(*exclusive time for accepting EC applications all BLS centres*)

5. EC application fee, ICWF charges and BLS service fee will be waived off for those applicants who do not have the means to pay these fees. Should any applicant so desire, they can avail of form filling, photograph preparation and SMS services from BLS (optional) at a total cost not excluding AED 25/-. In case of any query/clarification/further documentation, the Embassy/Consulate will contact the applicant directly.

6. Applicants are advised to collect their EC from the BLS Centre within 5 working days as per the delivery time mentioned on their receipt.

7. After obtaining the EC, applicants will be required to visit the respective Immigration office for visa cancellation and completion of their exit formalities.

- For Abu Dhabi: Visa Section, 1st Floor, Abu Dhabi Immigration, Airport Road
- For Dubai: Immigration Centre at the Civil Aviation Security Center near Terminal 2, Dubai Airport

8. This facility would be extended until December 20, 2020 and is intended to enable distressed/stranded Indian nationals to avail of the UAE's visa fine waiver scheme and travel to India by December 31, 2020.

## Undertaking for issuance of the Emergency Certificate (EC)

- I understand that EC is a one time travel document issued only for the purposes of entering India. I also understand that with issuance of EC all my previous valid travel documents (passport, EC if any) would be cancelled.
- I hereby undertake that I have not been involved in any criminal case, hindering my travel back to India.
- I hereby confirm that after receiving the EC, I will complete all necessary exit formalities at the immigration centre and make necessary arrangements for travelling back to India.
